1. SOURCE OF THE INFORMATION

Pursuant to the 'X-table' regulation, the Commission receives from the Member States, on an annual basis, data on the payments made to the beneficiaries of the European Agricultural Guarantee Fund (EAGF) for further use in the context of the audit procedures as well as for monitoring and forecasting purposes.

2. SCOPE OF THE DISTRIBUTION FIGURES (EU27)

The attached figures cover the expenditure paid as direct aid according to Regulations No 1782/2003 and No 73/2009 for financial year 2013 and are based on the total amounts aggregated by every individual beneficiary identification code ('unique identifier').

3. LIMITATIONS AND COMMENTS

3.1. While in general data quality is adequate for use in the audit activity, care must be exercised over use of the data for other, analytical purposes. The requirement for a 'unique identifier' came into effect on 1 January 2003 following the introduction of the new IACS Implementing Regulation¹. Despite the Member States' continuous efforts, small inconsistencies in the application of the 'unique identifier' cannot be totally excluded. The attached tables therefore present "indicative" and not totally precise figures.

3.2. The Member States have been invited to confirm the order of magnitude of the draft 2013 figures upon which no substantial differences were notified.

3.3. Figures are given according to the following sub-division: "All direct payments", "Decoupled direct payments" and "Coupled direct payments".

3.4. Numbers of beneficiaries less than 10 have been made invisible.

3.5. All Member States provided their data in EUR.
